STUDENT DRIVER AGREEMENT

All drivers are subject to the laws of the Arkansas Department of Motor Vehicles. Violators of state law will be reported to the local authorities. GMCS cannot assume any responsibility for damage done to a vehicle while on school grounds.

Initial each blank indicating you understand each statement:

____ This permission form must be signed by me, my parent/legal guardian in order to operate a motor vehicle on campus. This form is only good for the present school year and must be renewed each year.

I may only drive my vehicle to and from school

If my parent revokes their support of my driving privileges, the school will cancel this permission.

I may not drive other students except the person(s) listed.

Other students may not ride in my vehicle without written permission from their parent. Signed permission must arrive at the school as soon as the student arrives at school in the morning.

I must register my car with the school office at the start of each school year and receive permission/parking permit in order to park on school grounds. I must re-apply each year.

I may park only in my assigned parking space.

I may not hang out at my car in the mornings or afternoon or return to it during the school day.

I may not leave the school before regular dismissal time without permission from the Administrator.

I am responsible for the witness and testimony I project in having my car on campus. Articles visible in my car are considered to be articles brought to school. I must not bring weapons, cigarettes (tobacco or electronic), alcohol, drugs, objectionable music, or other inappropriate articles to school. Regular disciplinary procedures will apply if these objects are in my car.

I understand that I must drive carefully when on the school property. Discourteous driving, or other dangerous activity, when reported to the office, will be investigated and may result in suspension of the driving privilege.

I must yield to pedestrians.

I may not pass any moving vehicle on school property.

I must stay off school grounds after being excused, unless attending an extra-curricular activity or school function.

I am expected to be on time to school. Tardiness may result in suspension of driving privileges.

If I violate any of the above regulations, or act in ways that could result in the harm of others or the property of others, I shall be subject to the following penalties:

- 10-day loss of motor vehicle privileges for the first offense
- 20-day loss for the second offense
- loss of privileges for the remainder of the year for the third offense

If I lose driving privileges, I may not drive my car or others' cars on campus.

If I have a hardship license, I will drive to and from school ONLY. Only licensed drivers may ride with me. I am not permitted to drive another person's vehicle.

Any issues not specifically outlined in the above regulations will be handled at the discretion of the administration.
